Minutes of MEETING of RENHOLD PARISH COUNCIL held on Wednesday 4th December 2019 at 7.30pm at Renhold Village Hall

PRESENT:- Parish Councillors: Mrs. Quince (Chair), Mr. Cook (Vice Chair), Mrs. Dean, Mr McIver, Mr. Warwicker, Mrs. Brunsdon, Mrs. Gribble, the Clerk Mrs. Barnicoat and five members of the public.

1. WELCOME AND APOLOGIES FOR ABSENCE TO BE RECEIVED: - Borough Councillors Stephen Moon, Phillipa Martin Moran Bryant, Tim Creswell and Parish Councillor Mr. Rayner and Mr. Polhill, had sent apologies, which were accepted.

2. DECLARATIONS OF PERSONAL AND PREJUDICIAL INTEREST TO BE DECLARED FOR THE MEETING: - Cllrs. Dean and Warwicker declared an interest in the Gardening Club's application for financial assistance. No further declarations of interest received for the meeting.

The Chair adjourned the meeting for the next item.

3. OPEN FORUM: -

Concern raised regarding the rain water next to the footpath at Church End, the down pipe is flowing straight onto the verge and the drain is blocked. This be reported again as the area keeps freezing and is dangerous; particularly for churchgoers and school parents and children. Concern continues over the lack of planning enforcement in this area, the utility box on a listing building remains visible. This to be followed up.

Concern to be reported about the two drains on the bridge by the traffic lights at Church End that are blocked.

Reports of overgrown hedge on the path between Brickfield Road and Polhill Arms, Cllr. Gribble has reported to UK Power Networks.

Enquiry regarding Bedford Town Football Club and the new pavilion in Fiona Way opening.

Overgrown hedges in Cranbourne Gardens reported as an ongoing issue. Clerk to organise letters to the properties concerned.

Follow up for timescale of dual waste bin repair that was reported some time ago in Cranbourne Gardens, dog waste bin in Odin Close. The Clerk to collate these items with some other outstanding matters and seek support from the Borough Councillors to get these items actioned more promptly.

The Chair reconvened the meeting for the next item.

4. PLANNING AND DEVELOPMENT: -

a) Planning Committee feedback for 18/02496/MAF demolition of one dwelling and erection of 14 dwellings at 27 Hookhams Lane and Land Adjacent – the resident communication list had been kept updated. The application decision was deferred by the Planning Committee to allow members to undertake a site visit. Borough Councillor Moon, Parish Councillor Quince and resident Janet Goodman addressed the committee with their concerns. Awaiting information on the site visit. Strict guidelines have to be followed during a visit. It was agreed to circulate the date and time widely to encourage local residents to attend.

b) Update on 19/01974/MAO outline application with all matters reserved except access for up to 400 dwellings, land for a new primary school, open space, drainage, footpath improvements and

vehicular access via 25 Hookhams Lane to include consideration of engaging a planning consultant to represent the Parish Council for both the 28 and the 400 and to record thanks to those who have already helped with enabling residents to engage so fully in the consultation process. The Parish Council responses had been submitted and shared with residents via the website and circulation list. It was agreed that residents should be reminded that they can still respond to both applications. Clerk to follow up. The Highways Officer reports to these application were available and both sought further information from the applicant. These to be shared with residents.

The Council discussed the idea of seeking professional guidance with regards to these planning applications to support the Council with the strongest possible representation at Planning Committee meetings. It was unanimously agreed by those present that the Councillors should look into this and report back at the next meeting.

c) Update 19/02194/MAO outline application for the demolition of a dwelling and the erection of up to 28 dwellings with all matters reserved except for access at Land East Of Hookhams Lane – communication with the Officer had continued and there has been no further update as to when this application may go to Committee. Clerk to monitor.

Cll. McIver demonstrated the possibility of downloading the planning documents ahead of the meeting and then displaying them electronically using a 32 inch high definition screen (priced at £300) so that members of the public and Councillors could view them more easily. An alternative suggestion was to investigate the possible use of a projector and to arrange a demonstration, so that we could compare the two. The Council unanimously agreed in principle to approve expenditure of up to £300 for a suitable medium, once both options had been explored.

d) 19/02407/LBC replacement windows to modern kitchen extension at rear of the White House, 2 Woodfield Lane – the Parish Council reviewed the application and had no objection to the application.

e) 19/00200/FUL erection of 2 storey front extension to accommodate garage with room over, raising of bungalow roof and installation of dormer windows to all elevations to facilitate loft conversion at Elmleigh, 18 Wilden Road – further amended plans received. These were reviewed by the Parish Council, and there is considerable concern that the proposal is ahead of the building line of the garage belonging to the bungalow next door. This would set a precedent and would have significant impact on the street scene. The Council feel that the plans should be amended to follow the building line of the garage of the bungalow next door.

f) 19/02433/FUL two storey and single storey rear extension at 32A Church End – the Parish Council had no objection to this application.

g) 19/02560/FUL erection of detached garage at South End Barn, The Grain Store, Ravensden Road – the Parish Council have concerns regarding this structure and wish to object to this application. The building is significantly ahead of the building line, so it would change the street scene of the building and its setting and would set a precedent on this side of the road. In addition, by having such a structure which is standalone it raises concern over its potential to be developed further in the future. Therefore the Council ask that if the Officer is minded to approve the application, that a planning condition be applied to ensure this structure cannot be occupied for residential use.

h) Other planning matters to include application decisions -

18/02565/FUL application regarding land at rear of Wentworth House – notification this has gone to appeal. Further PC response sent.

19/00066/FUL - Condition 10 - Archaeology – partial discharge of condition 1 part i only permitted, for erection of three detached houses all with detached garages and parking - Land at Former Site Of The Three Horseshoes

It was raised that there had been a possible planning application for 67 Church End. Cllr. Cook declared an interest and took no part in the discussion. Clarity given on the right way to engage with the request to the local authority. Clerk to respond. Barn East Of 67 Church End Renhold Bedfordshire 19/02419/CPNQ – the Parish Council understand that this application has been received by the Borough Council. They kindly ask that the Officer considering the proposal is aware that there are currently a mating pair of barn owls residing in this barn, which as a protected species, must be safeguarded. Peter Wilkinson, a local expert, monitors/observes their movement so the Council feel that if such a change to residential is being proposed then actually a full application is needed so appropriate conditions can be applied such as ensuring there is a replacement nesting box. The Council also have concerns over having a vehicular access at this point onto Church End which has limited visibility splay and it is in very close proximity to the road narrowing and associated traffic lights. So again feel a full application is needed for this site.

The Parish Council considered the best management of planning within Council meetings. It was agreed that a Planning Committee meeting would only be called in exceptional circumstances. With a move to viewing plans electronically during meetings, and a small group of Councillors reviewing the applications ahead of the meeting with site visits, it was agreed that this is a more efficient way of managing lengthy applications.

5. MINUTES OF THE LAST MEETING:-It was resolved to approve the minutes of 17th October and 7th November, signed by the Chair as a true and accurate record.

6. BOROUGH COUNCILLOR REPORT: -

Report received and circulated.

7. HIGHWAYS MATTERS WITHIN THE VILLAGE: -

a) Update on Hookhams Lane traffic calming options, consultation for a safe pedestrian crossing at Church End and additional vehicle activated signage in the parish – very frustratingly there had been no response or feedback to any of the reminders sent to the Borough Council. Cllr. Quince to follow this up with Andy Prigmore and the Borough Councillors. Feedback had been received regarding the vehicle activated signs on Norse Road.

b) Consideration of forming a dark skies policy for parts of the parish – Cllr Bryant had circulated associated information following last meeting for Cllr. Gribble to consider. Document had been drafted, to be shared with Councillors. Discussion on neighbourhood plans, whether this is a way to safeguard the parish. Clerk to inquire with Bletsoe parish about their approach.

Other highways matter, resident communication regarding Traffic Regulation Order, agreed Clerk to feedback that it would be best to liaise directly with the Police.

8. FEEDBACK FROM MEETINGS COUNCILLORS HAVE ATTENDED

9. VILLAGE MATTERS: -

Asset inspection review undertaken. Identified items discussed. Items to be actioned: Top End vegetation brambles to be cut back by the noticeboard, bench at War Memorial needs checking, Church End glass in noticeboard needs reviewing, Church End vegetation at bus shelter to be reviewed. It was agreed that Clerk should liaise with Conservation Officer as noticeboard is fixed on to a listed building.

CCTV in Water End is continuing to be pursued.

10. GDPR CONSIDERATION OF OPTIONS RELATING TO COUNCIL EMAILS AND UPDATE ON WEBSITE OPTIONS: -

Cllr. McIver has been liaising with another local council, which is working on creating a statement for Councillors to sign to show commitment to GDPR. Clerk to link resident offering assistance and expertise in this area with Cllr. McIver. New website continues to be built. Thanks given to Cllr. McIver.

11. FINANCE MATTERS TO INCLUDE: -

It was resolved to pay the above cheques.

Given the increasing number of items arising between meetings that require expenditure to ensure items are progressed promptly, for example with the Hookhams Lane information literature, War Memorial preparation for remembrance, it was agreed that on the production of receipts that up to £250 be authorised for Cllr. Quince to be reimbursed for associated Parish Council expenditure per meeting. This would be reviewed in January as part of the budget review.

c) Financial assistance application to be reviewed – Renhold magazine application reviewed, considered, and unanimously agreed to award £1108 towards the publication of the magazine.

The Gardening Club application had been circulated. Cllrs. Dean and Warwicker declared an interest and took no part in the discussion. Cllr. Quince had sought guidance from BATPC. It was unanimously agreed to fund up to £25 for up to twelve meetings from January 2020 to December 2020, at a parish venue of their choice, with the Council making payment directly to the chosen parish venue.

The Sports Club application circulated and reviewed. Council resolved to send a letter asking for some further information.
